Dear Mr. Singleton.

We received the notice informing us of the SCHSL's decision regarding our self-reporting of the girls' soccer team's violation of open/closed season practice.

We fully accept the SCHSL's decision to limit the team to one practice, inability to host any events, and the \$500.00 fine. However, we would like to appeal the inability to participate in the post season.

The girls' soccer coach received clear notice from the athletic director that he could not train soccer players during closed season. The soccer coach acted independently and in isolation from the directive that was provided to him. Due to the coaches' actions, he was relieved of his duties as South Pointe High School's girls' soccer coach immediately following the investigation and findings.

We strongly believe the actions of the coach does not represent our soccer program, athletic department, or school. We believe our actions to terminate the coach due to his independent actions, will ensure our soccer team can move forward positively and without any further league violation(s). We further believe the acceptance of our appeal will not allow our players to pay the cost of a decision made independent from them and limited their ability to compete beyond the regular season.

This letter is written to bring to your attention an investigation that was conducted and finalized yesterday. The investigation revealed a SCHSL violation of South Pointe High's soccer team. The investigation revealed the varsity girls' soccer coach, Javier Marin, was involved in multiple off-campus practices during closed season with SPHS girls' soccer players. The confirmed unauthorized practice dates include 8/19, 8/26, 9/6, 9/16, 9/23, 10/11, and 10/14. The investigation is on-going to confirm all the facts of the violation to include the name of the four players involved.

Lastly, we are in the process of finalizing disciplinary actions to be taken against the coach, which may include termination.

Dear Skip Lax,

This letter is written to self-report a possible SCHSL violation of the Junior Varsity Football Team. Due to a change in the Thursday, October 31, 2019 JV football game vs. York HS to Monday, November 4, 2019, the athletic director understood we would not be in violation if eight JV football players played on Friday, November 1, 2019 in the varsity game and play again Monday, November 4, 2019 in a October 31, 2019 make-up JV game. The game was changed from Thursday, October 31, 2019 to November 4, 2019 against York HS due to inclement weather. The athletic director did not properly communicate to the coach the SCHSL regulation. It was mistaken that since the JV players did not play the same week as Friday's game, they could play Monday, November 4, 2019 because it was the following week.

We understand the League will conduct its' investigation and determine any possible violations. In the meantime, we would like written feedback prior to our 7:30 p.m. playoff game on Friday, November 8, 2019 to confirm the eight players are eligible to play in the November 8, 2019 playoff game against Greer HS.
