Dear Mr. Ludley:

I have reviewed all the information submitted by Greer High School, including the statements submitted in support of the hardship request. However, based upon the information provided to me, I have determined that the degree of hardship necessary for me to grant a waiver for Timothy Dalton White is not evident and, therefore, I must deny the request. In denying the request for an exception to the eligibility rule, I considered that the circumstances are not totally different from those that exist for the majority or even a small minority of students; that the student transferred without a bonafide change of address; that the alleged bullying and hostile environment by the coach have not been confirmed by the former school's administration (South Pointe); and that the decision to transfer was a matter of choice by the household involved. However, while I cannot grant retroactive eligibility, if eligible in all other ways other than residency, if requested, I will grant eligibility at all levels in all sports in which the student did not participate during the 2019-20 school year.

The League's Executive Committee will meet on January 13, 2021, at the League Building in Columbia to hear appeals. If you desire to appeal this ruling, please notify me in writing by January 7, 2021, at 1:00 p.m. Also, you are to refer to page 1 in the League's Bylaws for the procedure to be followed. Each committee person must receive a complete copy of the hardship request prior to January 10, 2021. Additionally, if you plan to have legal representation (i.e. attorney) at the meeting, please notify this office along with the appeal request. Please note that the meeting will proceed in open session pursuant to the South Carolina Freedom of Information Act (FOIA), S.C. Code Ann. § 30-4-10, et seq. If you wish for the meeting to be closed to the public, please be prepared to make the request at the beginning of the meeting, identifying the specific exemption under FOIA that applies to your case.

Dear Mr. Ludley:

This letter is in response to an ineligible student athlete who participated in boys cross country and track at Greer High School for the 2019-20 school year. As you are aware, the league office received information via email pertaining to the eligibility of several athletes who participated in cross country and track at Greer High School during the 2019-20 school year and the 2020 fall season. The league immediately made Greer High School aware of potential issues with student athlete eligibility on October 30, 2020 upon reviewing the information.

After initially reaching out to Greer High School regarding the eligibility of D. White for the 2019-20 school year, the league and Greer High School had additional correspondence pertaining to the status of his eligibility and his participation in spring sports at Greer High school. In your letters of response you indicated that he participated in both boys cross country and boys track for Greer High School during the 2019-20 school year. In your last letter you stated: "If the retroactive hardship exception for Dalton is not accepted by the SCHSL, then he would be considered ineligible for the 2019-20 school year because the transfer was not processed correctly."

Based on this statement and all of the information provided by Greer High School, I have determined that Greer High School allowed an ineligible to participate in boy cross country and boys track during the 2019-20 school year. In accordance with the Rules and Regulations of the South Carolina High School League, Greer High School will fined \$500 for each sport that an ineligible was allowed to participate (\$1,000 total). In addition to the fine, Greer High School will have to notify your opponents that you are forfeiting any individual points earned and/or medals earned by the ineligible student athlete as well as any team championships won in both boys cross country and track.

After reviewing the results of the 2019 SCHSL 4A Boys Cross Country State Championships, it has been determined that without the ineligible participating that Greer High School would have finished in second place. Greer High School will need to notify the 2019 Runner-up in Boys Cross Country of the new results of the state meet.

Commissioner Singleton,

On August 20, 2019, Timothy Dalton White enrolled at Greer High School as a transfer student from South Pointe High School. After further review, we believe that his transfer was processed incorrectly and that the correct process would have been to request a hardship exception for his athletic eligibility.

We believe that Dalton would have qualified for application for a hardship exception due to the separation of his parents and because he was experiencing a contentious environment between his family and certain personnel at his former school. Dalton's father (Tim White) moved to Greer, SC due to a separation with his wife and also for the purpose working in Greenville County in the summer of 2019. After speaking with Mr. White about the reason for transfer, it was apparent that Dalton was not progressing in a positive manner in his social, emotional, and academic growth at his former school. During the summer of 2019, Mr. White and Dalton sought a new school environment for Dalton to thrive socially, emotionally, and academically. We have found no information that would have deemed Dalton ineligible by the rules of the SCHSL if his residence had not changed.

In closing, we believe that the circumstances surrounding the transfer of Timothy Dalton White would have justified applying for a hardship for his athletic eligibility due to his parent's separation and because of a contentious environment with certain personnel at his former school. At this time, Greer High School is requesting a retroactive hardship exception for Timothy Dalton White to be eligible during the 2019-2020 school year.

I am writing this letter in reference to my child, Dalton White, an incoming transfer student from Rock Hill School District 3, South Pointe High School.

In a short synopsis, I would like to request or petition a "hardship" transfer request.

There are multiple reasons and documentation can be supplied if required, but in brief:

- (1) I personally have moved to Greer, SC. I have changed my residency with everyone, including the DMV regarding my licensing and vehicle registration. I have an executed lease beginning August of 2019, all utilities in my name as well. Dalton changed his DL as well.
- (2) There has been an amicable split between his mother and me. We agreed years ago, based upon a terrible custody battle with his older brother, that we would never put our other children through that.
- (3) South Pointe was no longer able to provide a "safe" environment for Dalton. They have violated his federal 504 status on two occasions. The first resulted in a trip via ambulance from the school to the hospital. The former AD (who was present in all of our educational/strategic meetings with the school regarding his condition) provided him with his life-threatening food to eat. The second came from his Head Coach for Cross Country. She purposely planned and excluded him from a team outing, so that she could reward other teammates with a meal from a business unsafe for Dalton.
- (4) Due to the incident revolving around the Head Coach and her violation, a series of bullying and hostile environment instances occurred towards Dalton. No amount of intervention from the school nor District Offices, could remedy the situation. I met in person on multiple occasions with all parties involved to no avail.
- (5) It became bad enough, my son requested the ability to "drop out", get his GED, and forget running.
- (6) The former school's AD, Adam Hare, suggested to us that we "move" him to somewhere he could be safe.

I sincerely thank you in advance for expediting this request. Since this is an inter District transfer, with the written blessing from the former school, I do not think it is fair to punish this kid for an environment that wasn't safe for him to be in.

Good Morning Mr. White,

This communication is a follow up from our initial telephone conversations on November 12th, November 13th, and a follow up conversation on November 19th with Mrs. Parker and you. I understand we both made several attempts to speak again on November 23rd and 24th, but were not able to speak again until today.

During our telephone conversation on November 12th Mrs. Parker and you shared your concerns about a letter you received that was written by SPHS volunteer Cross Country Coach Robert Krolewicz to the SCHSL regarding the eligibility status of your daughters, Greta and Maddie White, who transferred to Greer High School in January 2020 and participated on Greer's Cross Country Team this season. In addition, you also shared the historical context as to the experiences of your son (Dalton) and daughters on South Pointe's Cross Country team which led you to making the decision to transfer them to Greer High School. As I shared at the time of the transfer in January 2020, I respected your decision to do so and would provide any reasonable support I could to assist with the transfer process. I assumed the transfer went well since there was no further communication from you or anyone from Greer High School.

During the conversation Mrs. Parker and you conveyed your concern about the depth and magnitude of the private information that had been shared in the letter. You also communicated that the tone of the letter was harassing and demonstrated your daughters being targeted by Mr. Krolewicz. I advised you during the call that Coach Hare nor I knew about the letter, never endorsed such a letter, nor had we seen the letter. I shared with you that I was concerned that the letter had been written by an affiliate of SPHS and Mr. Krolewicz had operated independently and not on behalf of the school nor as a representative of the school. Mrs. Parker and you also communicated that a person had shared with you that Coach Sacco, while in a circle of adults and coaches at a Cross Country meet in September, Coach Sacco stated, "I am going to ensure the White girls are not eligible."

I advised you I would speak with Mr. Krolewicz, Coach Sacco, and Coach Hare to investigate these matters and follow up with you by November 19th. I spoke with Mrs. Parker and you on November 19th and shared the following from the November 18th meeting with Mr. Krolewicz, Coach Sacco, Coach Hare, and myself:

1. Mr. Krolewicz did confirm he wrote the letter and sent it to SCHSL independently and without Coach Sacco's or school's leadership knowledge.

2. A school investigation was conducted regarding the alleged comments Coach Sacco made about the eligibility of your daughters.

Due to this being a personnel matter involving Mr. Krolewicz and Coach Sacco, any actions or next steps will remain confidential. Lastly, Greer's principal contacted me on November 24, 2020 to share insight on Mattie and Greta's transition to Greer High School. He also asked that I write a letter of support for their transition to Greer High School. I agreed to do so and will send the letter of support to him by December 2, 2020.

I appreciate and respect your professionalism and communication with me the past few weeks to address your concerns. In conclusion, this letter denotes the closure of the investigation by South Pointe High School. I hope this has brought some resolve and is beneficial to you and your family.
